- Respondent must own 85% of all sound and auxiliary equipment used to fulfill this contract. Your insurance must cover any leased or borrowed equipment for damage to the equipment and general liability.
- Proof of ownership may be required. If you are leasing or borrowing equipment from another party, a signed letter, on the company's letterhead, from the company you are leasing or borrowing the equipment from stating what type of equipment will be leased and that the equipment is available May 11 – May 14th, 2023; May 9th – 12th, 2024 and May 8th – May 11th, 2025 is required.
