Completed reservation form, credit card authorization form for the trailer space fee must be in the fair office by **Monday, March 10, 2025 - 5 p.m. (Applications will begin being received March 3, 2025)** A Fair livestock entry form must accompany the application or already be on file in the fair office. Those wishing to reserve a space will be asked to provide a credit card number but it will not be charged unless they are selected. *(Credit Card only, no cash or checks accepted)*. The drawing will take place on Wednesday, March 19th and once the credit card payment is verified then the person on the reservation form will be notified via email. **Trailer space reservation fee is \$200.** There are only 6 spaces available for trailers over 32' in length, they will be assigned on a first drawn bases during the drawing. If you have an oversize trailer (over 32') and those spaces are filled then you will not be eligible for another space unless you specify on the reservation form that you are able to get a trailer 32' or smaller for a space.

DIXON MAY FAIR LIVESTOCK RV POLICY

1. Due to a high demand for RV Spaces, there is a limit of one (1) paid application per residence. All space reservations must be accompanied by an entry form in the livestock department. Horse, Dogs and Cavy exhibitors are not eligible for a trailer space.
2. RV spaces WILL NOT be available to residents of Dixon, students within the Dixon Unified School District boundaries or members of Dixon Clubs/Chapter, even if you live out of the Dixon boundaries but belong to a Dixon Club/Chapter.
3. Dixon May Fair will conduct a random drawing to determine livestock trailer spaces for the 2025 fair. Completed reservation form, credit card authorization form for the trailer space fee must be in the fair office by **Monday, March 10, 2025- 5 p.m.** A Fair livestock entry form must accompany the application or already be on file in the fair office. Those wishing to reserve a space will be asked to provide a credit card number but it will not be charged unless they are selected (Credit card only, no cash or checks accepted). The drawing will take place on Wednesday, March 19th and once the credit card payment is verified then the person on the reservation form will be notified via email. **Trailer space reservation fee is \$200.** There are only 6 spaces available for trailers over 32' in length, they will be assigned on a first drawn bases during the drawing. If you have an oversize trailer (over 32') and those spaces are filled then you will not be eligible for another space unless you specify on the reservation form that you are able to get a trailer 32' or smaller for a space
4. A trailer space permit and your arrival time will be mailed to you prior to fair. This must be visible at all times while on the fairgrounds.
5. There is no guarantee of electricity or water in the spaces.
6. Trailers will not be pulled in prior to **Tuesday, May 6th at 1 p.m.** Trailers can be pulled in Tuesday, May 6th from 1 p.m. to 8 p.m. and Wednesday, May 7th from 1 p.m. to 7 p.m. All trailers must be in place by Wednesday, May 7th by 7 p.m. Trailers must remain stationary for the duration of the exhibitors stay. **All trailers must be removed by Sunday, May 11th no later than 11 a.m.** The Dixon May Fair reserves the right to take any and all appropriate action to evict trailers or vehicles which are not removed by the deadlines specified. All costs associated with evictions from the trailer area will be the responsibility of the registered owner of the trailer or vehicle. There is no RV parking in Hall Park Parking Area or any Fairgrounds parking lots or areas. Violators will be towed at owner's expense.
7. RV's will be limited to a maximum size of 32' with the exception of the 6 spots designated by the Association. Anyone not adhering to these rules will be removed from the trailer park, **NO EXCEPTIONS AND NO REFUNDS.**
8. RV's must be within the designated space line and not encroaching on their neighbor's space. A trailer with pop-outs may not fit and may be asked to pull in the pop-out if it is over the lines, inhibiting the neighbor from entering their trailer or causing an unsafe situation. Trailers should not be touching each other.
9. No vehicles are allowed in the Trailer park or on the fairgrounds.
10. Only registered chaperones, leaders/advisors, exhibitors and siblings are allowed to camp in the trailer area. No more than five exhibitors are allowed per trailer.
11. One responsible chaperone (parent or leader) 25 years of age or older is required per trailer. Siblings are not considered chaperones no matter the age. No Junior Exhibitor, even if 18 or over, can stay without a chaperone. If there is no chaperone after 10:00 p.m. thru 6:00 a.m. you will not be able to reserve a trailer space for 2026 Fair, and your trailer will need to be removed.
12. The adult leader or parent with trailer will be required to sign the application acknowledging they have read these rules and agree to abide by them.
13. Gas Barbecues only! No open, wood or charcoal fires or BBQ's permitted. No Barbeques allowed to be used between the hours of 10 p.m.- 6:00 am **absolutely no open fires are allowed.**
14. No waste-water buckets may be used.
15. No noise after 10:00 p.m.
16. **No dogs are allowed at the Fair except for service dogs.** No livestock is to be in the overnight camping area at any time.
17. **Use of illicit drugs or use of alcohol by exhibitors, parents, chaperones, leaders or advisors, will not be tolerated.**
18. Alcohol Policy: The following are the procedures that the Dixon May Fair will follow to minimize any alcohol-related problems:
 - 1) We will not allow alcohol to be brought onto the fair grounds. No ice chest, six packs, bottles or cans of any kind will be allowed on the grounds.
 - 2) No drinking in parking lots.
 - 3) No Adult exhibitor will be allowed to consume alcohol while on duty or in their exhibit area.
 - 4) ZERO tolerance of minors and alcohol. Minors exhibiting at the fair will have their exhibit removed from any competition and sale and will be stripped of all awards.

RESIDENTS OF THE RV PARK WILL BE ALLOWED TO BRING IN FOOD AND NON ALCOHOLIC BEVERAGES IN ICE CHESTS PRIOR TO 9 A.M. DAILY. ICE CHEST, BOTTLES AND CANS MUST REMAIN INSIDE YOUR RV/TRAILER. NO ALCOHOL IS TO BE BROUGHT ONTO THE FAIRGROUNDS.
19. **No firearms or weapons** are permitted on the fairgrounds. Fair management reserves the right to determine what is considered a weapon.
20. There will be Security patrol after 10:00 p.m., ANY violation of rules, by exhibitors, family or guests will be referred to Fair management for appropriate action.
21. Violation of rules or fair policies is grounds for loss of trailer spaces.
22. Minor Violations of the rules will result in the following consequences:
 - a) Verbal warning
 - b) Written citation
 - c) Removal of trailer from fairgrounds
23. Serious violations of above rules (i.e.-use of alcohol or drugs, physical violence, or possession and/or use of fire arms or other weapons) will result immediate ejection from the Fairgrounds, loss of privilege to sell in the Jr. Livestock Auction, entries removed from Fairgrounds, and loss of premiums.
24. **THERE IS NO RV/TRAILER/STOCK TRUCK PARKING ALLOWED IN THE HALL PARK PARKING AREA. VIOLATORS WILL BE TOWED AT OWNERS EXPENSE.**
25. No setting up canopies/tents/picnic tables/BBQ's outside of your area or in the fire lane. Violators will be removed.
